a.	Traffic Committee Resolution 1 (Jan 28 2025 Traffic Committee Agenda Item 6a) Be it resolved , the city commission hereby approves the traffic committee’s recommendation to upgrade the traffic signal at the intersection Coolidge Highway and Meijer Drive to have a box-span or mast arm configuration with dedicated left turn signals for north/south traffic when funding is available.	
b.	Traffic Committee Resolution 2 (Jan 28 2025 Traffic Committee Agenda Item 6b) Be it resolved , the city commission hereby approves the traffic committee’s recommendation to adjust the speed limit signs on Normandy Road to be 30 mph between Coolidge Highway and Crooks Road and authorize the mayor and city clerk to execute the associated traffic control order; to relocate the “prepare to stop when flashing” sign for eastbound Normandy Road to be closer to the railroad viaduct and to install a new “signal ahead” W3-3 sign.	
c.	Traffic Committee Resolution 3 (Jan 28 2025 Traffic Committee Agenda Item 6c) Be it resolved , the city commission hereby approves the traffic committee’s recommendation to change the speed limit to 30 mph on Gardenia Avenue between Campbell Road and Stephenson Highway and authorize the mayor and city clerk to execute the associated traffic control order; to incorporate pedestrian crossing improvements along Gardenia Avenue as part of the future road project.	
d.	Traffic Committee Resolution 4 Be it resolved , the city commission hereby approves the traffic committee’s recommendation to amend the committee bylaws to include annual elections of chair and vice chair positions each January.
