- a. Traffic Committee Proposed Resolution to the City Commission:
Be it resolved, the city commission hereby approves the traffic committee's recommendation to deny the request for on-street parking on E. Harrison Avenue between S. Main Street and Delaware Avenue, as outlined in agenda item 6a.
- b. Traffic Committee Proposed Resolution to the City Commission:
Be it resolved, the city commission hereby approves the traffic committee's recommendation to rescind the permit parking zone on W. Fourth Street from S. West Street to 130 feet east and to remove the permit parking sign, as outlined in agenda item 6b.
- c. Traffic Committee Proposed Resolution to the City Commission:
Be it resolved, the city commission hereby approves the traffic committee's recommendation to adjust the speed hump and traffic calming installation criteria on local streets to require an 85th percentile speed of 30 mph or higher, to adjust the traffic calming installation criteria on major streets to require a minimum 85th percentile speed that is 5 mph over the posted speed limit, to remove the striped bump outs (delineators and striping) on W. Lincoln Avenue, and to require a petition process for traffic calming installations on local streets as outlined in agenda item 6c.
