Opioid Use Disorder Navigator (OUD-N). The OUD-N provides specialized training needed to identify patients with opioid use disorders (OUD), coordinates with outpatient resources, follows up post discharge to ensure patients have engaged in outpatient substance use treatment, works with doctors and other medical staff to increase knowledge around OUD best practices, and will also develop a means of feedback from both the patient and staff involved with these services.
