40.00 Discussion/Deliberation

40.01 Order Authorizing a Construction Contract and Owner's Acceptance of Bidder's Offer With Visar Construction Co, Inc. Order No. 253-23

Commissioner Roberts read the Order by title. Mr. Benton explained that the Jackson County Roads and Parks Department, located at 200 Antelope Road, White City, currently has an old domestic and fire water supply loop from Camp White, and the pipes are constantly leaking resulting in many repairs over the years. The project will replace the existing water system that provides both domestic and fire hydrant water, along with some commercial water fill stations.

Facility Maintenance published an Invitation to Bid in the August 30, 2023, editions of the *Daily Journal of Commerce* and *Rogue River Press*; solicited at the Medford Builders Exchange; and posted to the Jackson County website. Five contractors appeared at the prebid conference on September 6, 2023, and three bids were received. Visar Construction Co, Inc, submitted the lowest bid, is qualified to perform the work, and should be awarded the Contract.

40.02 Order Authorizing an Intergovernmental Partnership Agreement With the State of Oregon,
Department of Consumer and Business Services, Building Codes Division.
Order No. 254-23

Commissioner Roberts read the Order by title. Mr. Benton explained that the Jackson County Development Services Department's current ePermit System Intergovernmental Agreement with the State of Oregon, Department of Consumer and Business Services (DCBS), Building Codes Division (BCD), is 10 years old and is being updated. BCD implements and administers the ePermitting system and its on-going maintenance for participating jurisdictions, at a cost savings to Jackson County.

Mercy Flights, Inc, and JCMH crisis staff co-respond to provide in-person services to individuals in Jackson County experiencing a mental health crisis.
